Deputy Larrick in plain clothes approached Joel that Mr. Jeschke is addicted to cocaine and now has Krista Michaels (Curt's ex-wife) also hooked on cocaine.

Donna Michaels (Krista's Mother)

Deputy Larrick stopped by Donna Michaels' house and proceeded to tell her that there is a restraining order against Mr. Jeschke for beating his ex-wife and that is why Mr. Jeschke is divorced.

Larry Musgrave (Friend of Deputy Larrick)

Larry has sat at the Candlelight Lounge and videotaped Krista and Mr. Jeschke out for an evening on numerous occasions. Mr. Jeschke observed Larry doing this every time they were in the Candlelight.

Janice Jeschke Beall (Aunt of Mr. Jeschke)

Deputy Larrick approached Janice in full uniform and on duty inside the Beaver County Courthouse on numerous occasions making statements that he has police officers watching Mr. Jeschke, that Mr. Jeschke is an alcoholic, and made comment that he is going to have police officers assault Mr. Jeschke and he had better watch his back. Deputy Larrick has also stated that Krista is using Mr. Jeschke. He also stated that Mr. Jeschke is taunting Deputy Larrick by driving past his house all the time and doing burnouts in front of his house.

Holly Betekeefer (Maiden Name: Barto) (Brother In-laws sister)

Deputy Larrick has told Holly that Krista (Curt's ex-wife) is using Mr. Jeschke and that Krista is nothing but a whore. Deputy Larrick has also been calling and stalking Holly. Deputy Larrick has a history of stalking Holly that goes back almost twenty years.

Krista Michaels formerly Larrick (Mr. Jeschke's girlfriend)

Deputy Larrick has made several comments to Krista (Curt's ex-wife) making threats about Mr. Jeschke. He advised that he would take care of the situation in his own way and stated, "He will kick the shit out of him."
